## GRANT REQUEST APPLICATION

The Mission at All Saints Lutheran Church is to give glory to God, share the good news of Christ, and grow in expression of faith and discipleship. Jesus asked his followers to “love your neighbor as yourself” and proclaimed, “it is more blessed to give than to receive” (Acts 20:35)

All Saints Lutheran Church established the All Saints Memorial Endowment Fund to provide a means to encourage giving to support the mission, vision, and ministry of the Church, separate and apart from our current and benevolent giving for the general operations of the Church.

The Endowment Fund Board oversees the Fund and has the responsibility of encouraging capital donations to the Fund, investing Fund assets, and **awarding grants in support of our mission and vision**. In doing so, we aim to enhance discipleship and stewardship, while expanding the ministries that God calls us to serve.

### Grant Requests

Grant requests may be submitted throughout the year by any All Saints Lutheran Church committee, group, or individual member of All Saints Lutheran Church, as well as charitable and religious groups or individuals not affiliated with All Saints Lutheran Church, so long as such non-member request is co-sponsored by at least two members of our congregation. **The Board will meet twice a year, in March and August, to review all grant requests and issue approved grants.** The number and amount of grants are awarded on a case-by-case basis, based on funds available for distribution and the merits of each request.

All grant requests will be reviewed and considered based on their ability to share the love and grace of God in our local communities or throughout the world. Funding priorities may be established by the Board from time to time, and requests must then fall within the funding priorities in order to have the best opportunity of being granted.
